#### 1. FY 2020 Board of Directors

- **a.** At the April 2, 2019 annual meeting, residents elected Tina Jay (1678) to the Coleson Cluster Association Board of Directors. The current board consists of the following four residents and terms:
  - i. Joseph Gems (1682) FY 2017-2020
  - ii. Katharine Bowerman (1660) FY 2018-2021

- **c. Secretary:** TANYA nominated JOE GEMS to serve as Secretary. KATE seconded. No nays. Joe Gems will serve as Secretary for FY 2020.
- d. Treasurer: Jonathan Miller will continue to serve as Treasurer for FY 2020.
