3. FY26 Financial Budget, Jonathan

Carl moves to approve the final FY26 Annual Budget.

Kari seconds the motion. | APPROVED by all Board Members present.

- FY26 Budget is based on current inflation rate, 3.7%
- Proposed budget sent out to Cluster residents, and comments were due March 21.
 - One resident proposed raising dues to a much higher rate.
 - o Historically, the Cluster did not raise dues for over 11 years.
 - o The Board has agreed to raise dues annually, according to the current inflation rate.

- Jonathan recommends putting \$20,000 in reserve, based on last year's profit and loss calculations.
- Carport Capital Improvement Project will be an upcoming expense for residents.
 - o Alternative financial options are being looked at.
 - New Reserve Study will help determine estimated cost for repairs.
- Reserve Budget is not for Capital Improvement expenditures.
 - Cluster to maintain between \$70,000 \$100,000 for stable fiscal health and emergency fees.

OTHER BUSINESS

- Can the Cluster save money by getting a free dumpster for clean-up events?
 - o FFX County will only provide a free dumpster once per year, within a limited window of time.
- Do we need to send out an RFP if additional tree service is needed?
 - o Board has agreed to cap tree service at \$15,000 for the upcoming year.
- Brent to reach out to Dominion to inquire about upgrading outdated meter near Green Path.
